PRESIDENT'S MESSAGE (continued)

Open Enrollment for City Retiree Health begins October 27 and runs through November 25, 2025. Note that these dates have changed since last year.

As you prepare to make your health coverage selections, it's also a good time to think about your overall well-being. Don't skip that annual physical, especially if you spent years exposed to smoke, diesel exhaust and hazardous materials. Firefighting was never just physically demanding in the moment, it carried long-term health risks many of us are only now starting to face.

Respiratory issues, heart disease and certain cancers are more prevalent among retired firefighters than in the general population. Regular checkups, cancer screenings and lung function tests can catch issues early, when they're most treatable. It's also a good idea to mention your fire service history to your doctor—many aren't aware of the exposure risks unless you bring it up.

Even if you feel fine, preventive care is key. You looked out for your crew your entire career—now it's time to look out for yourself. Annual physicals, updated labs and conversations about mental health are all part of that. Take the time, make the appointment and stay in the fight, because your health matters just as much now as it did on the job.

I hope to see many of you at the luncheon next month. Until then—take care of yourselves, stay healthy!

I hope everyone had a wonderful Now that fall is here. summer. remember that the Open Enrollment period has changed. Open Enrollment will begin earlier this year, on October 27, 2025. The early start will prevent enrollment from running into the holidays. October will be here before you know it, so please start thinking about your choices. I will send out information regarding the Open Enrollment Kickoff Day and Help Days when it becomes available. It does require thought and planning, especially if you're making the switch to Medicare, but I'm sure you are as grateful as I am we have medical coverage. Many are not so fortunate!

You may have ongoing questions about your coverage or questions about making a change this enroll-Please remember ment period. you can still call Care Counsel at (888) 227-3334 or the provider Customer Service number. Care Counsel is familiar with all the health plans and prescription formularies, plus it has knowledgeable representatives who can assist you throughout the year. I have used them when trying to decide about the best coverage and found them helpful and professional.

Also keep in mind that the offerings of the San Diego Public Employees

Association (SDPEBA) are available to you as part of your RFPA membership. From medical coverage to pet insurance, they have lots to offer. Just go to sdpeba.org and click on the "City Employees" tab to find all the choices available. Some members are under the impression they need to be a REA member (Retired Employees Association, for retired civilian employees) to enjoy these benefits, and that's just not true. The RFPA specifically addresses the needs of retired emergency personnel and has all the same benefits available to REA members. There is no need for duplicate membership.

Remembrance Day will be coming up in March 2026 to honor the retirees who passed away in 2025. Please think about coming out to support the families of those who served SDPD and SDFD. I will put out more detailed information on this when it is scheduled.

Retired Fire Engineer Richard "Rich" Ambler answered his last alarm on April 23, 2025. Rich was hired by the San Diego fire Department on August 22, 1969. He was promoted to Engineer on August 12, 1977. After more than 15 years of service, he officially retired from the Department on January 17, 1985. Rich loved surfing and waterskiing and is survived by his wife and two children. Rich was 79 years old.

The next Brother to answer his last alarm is retired Fire Captain Gary Gerdes. He passed away in June of 2025. At this time, there is no other information from the Fire Department on Gary's career details.

Retired Firefighter Warren "Griz" Erwin answered his last alarm on July 30, 2025. Firefighter Erwin was hired by the San Diego Fire Department on October 4, 1968. Warren retired on January 1, 1999 with more than 30 years of dedicated service to the City of San Diego. "Griz" loved diving, handball, backpacking, and horseback riding. He is survived by his wife and two sons. Warren was 83 years old.

Retired Battalion Chief Arthur" Art" Robertson answered his last alarm on August 15, 2025. Battalion Chief Robertson was hired by

the San Diego Police Department on July 10, 1961 and served on the Police Department for almost seven years before he switched to the San Diego Fire Department on April 1, 1968. Art was promoted to Fire Engineer on March 13, 1972, and then to Fire Captain on August 3, 1977. He was promoted to Battalion Chief on October 25, 1986. Battalion Chief Robertson retired from the Fire Department on December 31, 2002, with more than 41 years of service to the City of San Diego. It should be mentioned that Art was a veteran and served in the U.S. Army. He was also awarded a "Life Saving" award for saving the life of a police officer when he was assigned to MAST. Art loved outside sports and worked with horses in Arizona. Battalion Chief Robertson leaves behind a wife and daughter. Art was 83 years old.

The last of our brothers to answer his last alarm is retired Fire Captain Lanning "Lanny" Grubb, who passed away on August 25, 2025. Captain Grubb was hired by the San Diego Fire Department on January 3, 1966. Lanny was promoted o Fire Engineer on September 17,1973 and to Fire Captain on April 8, 1977. Captain Grubb officially retired from the Fire Department on June 30, 2002, with 36 years of service to The City. Captain Grubb was a carpenter before joining the Fire Department and enjoyed all sports. Lanny is survived by his wife, son, and daughter. Lanny was 84 years old. As always, we would ask you to keep these brothers and their families in your thoughts and prayers.

On a happier note, I would like to report on the retired SDFD Lake Tahoe Summer Trifecta. We had almost 40 people attend this three-day event this year and a good time was had by all. I would like to thank Jerry Swartfager, Dean Cherry, Bill Middleton and their wives for making this year's event possible. It does put your body to a test attending three parties in three days. There is some talk about changing things next year. I will keep you posted. NEWS YOU CAN USE

By now I am sure everyone is enjoying what I call "real summer" for retirees. All the kiddies are back in school, the warm weather is finally here, ocean water temperatures are finally tolerable without a wetsuit, and those coveted COLAs finally showed up in

our monthly retirement checks at the

end of July.

I wanted to share something that I feel is a great opportunity for our members. The San Diego Firefighters Federal Credit Union, located in the Tierrasanta neighborhood of San Diego, has opened up membership at the Credit Union to any member of the RFPA (retired San Diego Firefighters, Police Officers and Lifeguards). This offer also includes the surviving spouses of our members. This is a full-service credit union that you may want to check out for all of your banking needs.

Open enrollment for 2026 Retiree Healthcare benefits begins on October 27. The benefit period begins on January 1, 2026. The San Diego Public Employee Benefit Association (SDPEBA) will be hosting a "Help Day" on Tuesday, October 21, from 9:30AM – 12:20 PM at the Balboa Park Club. This is the same location as before. All of the vendors offering healthcare plans to City retirees will be in attendance, as well as staff from SDCERS, San Diego Retiree Health (BOS), the RFPA and the REA. If you are exploring healthcare benefits for the first time or possibly looking to change to a different vendor, this is a great opportunity to get all your questions answered.

As a side note to the above, the City of San Diego is planning to have parking meters in operation in several areas throughout San Diego, including in several areas of Balboa Park by October 1st. At this time, I have no idea what the city intends to charge for parking. We all know the city is usually quite slow in kicking off new programs, However, whenever there is a program to bring new money into city coffers, its efforts are hastened. So be aware that you may have to pay for parking to attend the Help Day event. Additionally, the city usually tacks on an additional

charge for people who use a credit card to pay for parking.

Some retirees may have noticed that there was a change in the amount they were being charged for their healthcare insurance (noted as "SD Retiree Health Deduction" on your pay stub). This actually only affected about 68 individuals. The error came about because San Diego Retiree Health (BOS) thought these individuals were Medicare eligible when, in fact, they were not. This error was corrected on the July 31 paycheck. If you were one of these individuals and you want or need more clarification, give BOS a call at 1-855-380-5898. Its hours are 5:00AM to 3:00PM on regular business days.

Lastly, I encourage all of our members to go to the BOS website www.sdretireehealth.com and create an account for easier access to your records. The same holds true at SDCERS. The best way to access all of your paycheck and tax record information is to sign-up on the Member Portal at the SDCERS website.
