phone numbers are up to date. These steps can spare your family tremendous stress.

A common question at the health fair concerned Medicare, especially regarding when to apply, given the rising cost of healthcare. This concern is entirely understandable. You can begin the Medicare application process three months before your 65th birthday and no later than three months after. Failing to sign up within that six-month window may result in a lifetime monthly penalty. Even if you think you may not need Medicare due to coverage through a spouse, it's still wise to contact Medicare at age 65 to clarify your situation. Several of my friends have done this and found it extremely helpful.

Please mark your calendars for January 12, 2026, when we will hold our first luncheon of the year and our RFPA board elections. 2026 will be a year in which we can all make an effort to gather more often and support one another as fellow retirees. I encourage anyone interested to consider getting involved as a board member; several of our current members have generously served for 15 to 20 years, and fresh participation is always welcome and encouraged.

This will be my final article as your President, and I want to express my heartfelt gratitude for all the support I have received over the years. It has been an honor to serve. I am confident that our incoming President, Charlie Hogquist, will do great things in the years ahead.

I'm going to start this month's article by announcing a tragic death—my computer. After 10 years it has slipped into the great electronic promised place in the far beyond. So, this means I'm using a standby computer with a different working format, so bear with me. I hope you all had a great fall and are looking toward to winter and the Holiday Season.

As time marches on, so does life. We continue to lose our brothers at a fast rate. We have had five brothers answer their last alarms since our last newsletter. Retired Captain Robert Stehlik answered his last alarm on Sept. 14, 2025. We do not have any more information on Robert's passing, but we will pass it on when we get it.

The next brother to answer his last alarm was retired Engineer Barry Bauer on Sept. 24, 2025. Barry was a veteran who served in the U.S. Navy as a torpedoman before joining the Fire Department. The San Diego Fire Department hired Barry as a Firefighter on Oct. 8, 1976. He was promoted to Engineer on Oct. 25, 1985. Engineer Bauer retired on Oct. 18, 2006, after 30 years of dedicated service. Barry is survived by his wife and son. Engineer Bauer was 79.

The third brother to answer his last alarm was Engineer Robert "Bob" L.

Buford. Bob passed away on Oct 17, 2025. He was a veteran who served in the U.S. Army before joining the Fire Department. He was hired by the San Diego Fire Department on Oct. 1, 1971, and was in the 4th Academy. (Bob and I were in the same academy). Bob was promoted to Engineer on Jan. 27, 1989; he retired from the Department on Nov. 17, 2000. He was an athlete and enjoyed all sports. He is survived by his wife, Margarita. Bob was 82 years old.

The next brother to answer his last alarm was retired Captain Albert "Al" Close on Oct 17, 2025. Captain Close was also a veteran who served in the U.S. Army prior to joining the Fire Department. Albert was hired by the San Diego Fire Department on February 13, 1966. He was promoted to Engineer on March 29, 1971, and to Captain on July 5, 1974. He retired from the Fire Department on Dec. 30, 1992, after 26 years of service. Captain Close is survived by his wife and three children. Albert was 88 years old.

The last brother to answer his last alarm was Robert "RC" Stevens who passed away on Nov. 20, 2025. At this time, the Department has not issued any information on RC. I will post any information on these brothers when we get it in the next newsletter. As always, we ask that you keep them and their families in your

thoughts and prayers. One of the best ways to honor not only these latest retirees but all the brothers who answered their last alarm in this past year is to attend the Fire and Police Remembrance Day Celebration on March 22, 2026. Put it on your calendar for next year.

Next year (2026) will be a great year. We start the year off with the Retired Fire and Police Association Quarterly General Membership Meeting and Luncheon. This great event is a good time to see old friends and have a few laughs. I would say the event is free, but it usually works out to cost about \$5 after you buy six raffle tickets (the food is free, though). The only thing you need to do is RSVP to Ron Moskowitz. If you say you're coming and later decide you can't make it for whatever reason (things happen), let Ron know so we don't get charged for your lunch. It is extremely important that you keep your beneficiary information current with SDCERS to avoid delays in receiving benefits intended for spouses and family members. Updated information (as of June 2019) regarding "Death Benefits for City of San Diego Members, Survivors & Beneficiaries" is now available on the SDCERS website at www.sdcers.org. Go to *RESOURCES* on the top of the home page and click on *DEATH BENEFITS*.

I hope everyone had a wonderful holiday by the time you read this. I hope you got to spend time with your family and friends, as retirement allows us the ability to catch up with everyone and travel when we like. I'm sure the payment of the Corbett benefit and the Annual Supplemental Benefit (formerly known as the 13th check) helped you to buy yourself or loved ones something special!

Open Enrollment is taking place as I write this. Many of you participated in the SDPEBA Help Day last month for assistance in making your choices this year. For those making no changes, not a lot to do. If you are Medicare-eligible this year—or have retired but are not yet Medicare-eligible and have questions—be sure to contact SD Retiree Health either by phone or online at sdretireehealth.com. A copy of this year's Open Enrollment information booklet is located on their site. too.

For those of you who earned enough quarters for Social Security benefits, please remember to submit your annual Benefits Verification Letter to sdretiree-health.com (our new medical benefits administrator). This will ensure your reimbursement for Medicare payments without interruption in 2026.

For those with Medicare, you should have received a letter about Benistar. Benistar is the new benefits coordinator for Medicare Part D prescription drug coverage. Questions about billing, coverage and authorization assistance related to Medicare drug coverage should be handled by them. If you did not, their contact number 1-800-236-4782.

There was a confusing letter recently sent by SDCERS concerning prescription drug coverage for those who have Cigna Surround as a supplement to Medicare. The bottom line is those with this coverage still retain prescription drug coverage through Express Scripts pharmacy in 2026. No benefits were lost. Simply go to express-scripts.com directly, as opposed to going through the Cigna member portal (you will no longer see a prescription tab there).

I recently sent out an email reminder to let us at the RFPA know if you've had a change of address, phone, email, or marital status. Believe it or not, SDCERS does NOT notify us of these changes, so we depend on you to keep us current. Many of you responded, but if you have made any of these changes and haven't told us, please email me at retiredfp.police@gmail.com so we can keep our roster current. This is important so the RFPA can offer you its services and so fellow retirees can contact you, too.

I'd like to remind everyone to update their beneficiaries. This can be done for your retirement benefits via the SDCERS website under the beneficiaries tab. It's good to check on this periodically to ensure it's updated or to make any changes. Same advice regarding your trust or will, especially if you've moved out of state—you need to update these documents to follow local laws.

In case you didn't know, there is a Power of Attorney form available on the SDCERS website under the "Members Benefits" tab. This form is for members who wish to designate another person to act on their behalf to manage their SDCERS account, in case of future incapacity or death. This turned out to be very valuable for me in dealing with Mike's dementia before his passing. Think about putting this in place with SDCERS should anything happen to you. It allows your spouse or other designated family member to act on your behalf concerning your retirement benefits.

Lastly, please consider pre-need arrangements. I know we cops don't like to talk

about this, but putting a plan in place is really a gift to your family. El Camino Mortuary consistently has offers available to our members. Our contact there is Rebecca Melendez, and she can help you make the right choices for your family. If all those choices are made in advance, then your loved ones can simply grieve your passing, as you have made all the difficult decisions for them. I know it helped me when I buried Mike.

For those who attended the October luncheon at the Bali Hai, it was a huge success. We had a big crowd, some excellent food and great presentations. I think everyone enjoyed seeing old friends and catching up.

We are planning our next "Range" luncheon Monday, January 12, 2026. We will continue to meet at the Holy Trinity Church Hall at 405 Ballard Street in El Cajon, since our Range remains unavailable—with no end in sight.

NEWS YOU CAN USE

City retirees should have an exceptional year, benefit wise. If you were like me and you started your city career at a relatively young age, you may not have had enough credits to receive a Social Security check when you turned 65. And, if you were hired before April 1, 1986, you didn't pay Medicare tax. When I turned 65, I still wasn't eligible for Medicare even though I had applied for benefits. However, when my wife turned 65, I then became eligible for Medicare on my wife's benefits.

Lo and behold, in January of this year, Congress "finally" repealed the Windfall Elimination Provision (WEP) and

in March, I received a lump sum Social Security payment retroactive to January 2024. I am also now receiving monthly Social Security benefits. I never thought I'd see that happen. Two things to keep in mind here: (1) the State does not tax Social Security benefits and (2) the Federal government does not withhold taxes on Security benefits unless you request them to. That being said, prepare yourself for owing more federal taxes for 2025, especially on that lump sum payment you may have received in March.

At the October luncheon held at the Bali Hai on Shelter Island, we had 140 guests. There were 143 sign-ups, eight no-shows and five walk-ins. As a reminder, we have to give the providers of the food at

our luncheons an expected headcount, usually about a week ahead of time. If you sign up and later change your mind about attending, please let Ron Moskowitz know. We have to pay for the food we have ordered even when people don't show up. At our January luncheon to be held at the Holy Trinity Church in El Cajon, we will be conducting RFPA board elections for five of our board members—three Fire and two Police. If you are interested in serving, please let us know so we can get the word out.

Every two months, SDCERS holds a Board of Administration meeting at its head-quarters at 402 W. A St. in downtown San Diego. Everyone should attend one of these meetings. You get info like when

Corbett and Supplemental COLA are approved and paid, 13th check payments and recent service and DROP retirements. Agendas for all the committee and board meetings are posted on the website at www.sdcers.org. At the November meeting, there were 70 retirements; 32 of

those were Safety retirees: 25 – Police, 4 – Fire and 3 – Lifeguards.

Here's an interesting fact you may not know, one that appears in many news articles and reports that complain about city safety personnel making so much money due to overtime. We all know the reason for this is the actual shortage of personnel to fill all of the shifts on the Police and Fire Departments. Here's how those departments stand today: 1,846 sworn police officers, 949 sworn firefighters and 98 fulltime sworn Lifeguards. The shortages are astounding.
